FUNDING YOUR REQUIREMENT

GOVERNMENT PURCHASE CARD (GPC)

The Government Purchase Card (GPC) program issues credit cards to purchase items, within a set scope. It was designed to increase procurement flexibility by simplifying some of the purchasing requirements for small-ticket items that have a micro-purchase cap of \$10,000 per order.



BLANK PURCHASE AGREEMENTS (BPAS)

BPAs establish a communication path between the customer, the contracting office and the potential vendor for future use. Once established, you can expect a rapid turn-around on delivery with no minimum purchase requirement.

DID YOU KNOW?

The FAR (13.303) establishes BPAs as a simplified method of filling anticipated repetitive needs for supplies or services—so exact items, quantities and delivery requirements do not need to be known in advance.
